### **Bite Me, Greg: Dr. T. Chaz Stevens Sending 25,000 Provocative "Ten Commandments" Posters to Texas Schools**

*Professional disruptor launches aggressive campaign against Texas' new classroom religion mandate.*

**Boca Raton, Florida (May 27, 2025)** — Texas Governor Greg Abbott is set to sign Senate Bill 10, which mandates displaying the Ten Commandments in every Texas public school classroom. Professional disruptor Dr. T. Chaz Stevens has just three words for Abbott: **"Bite me, Greg."**

In 2022, Stevens donated 2,500 Arabic-language "In God We Trust" posters to Texas schools. Not one poster was displayed, exposing selective religious freedom. Stevens is now escalating dramatically, planning to send **25,000 provocative, multilingual "Ten Commandments" posters** directly to Texas classrooms, testing the state's commitment to religious neutrality.

"If Abbott truly believed in religious freedom, my original Arabic posters would be on classroom walls right now," Stevens said. "Instead, Texas lawmakers ducked and ran. Let's see them dodge 25,000 multilingual, intentionally provocative posters. Be careful what you pray for."

- **Arabic Version:** Directly challenging Texas' religious inclusivity claims.
- **Satanic Edition:** Explicitly testing the boundaries of religious neutrality.

- **Reverse English Version:** Symbolically confronting backward-thinking legislation.
- **Ransom-Note Edition:** Amplifying controversial commandments like "Kill," "Adultery," "Steal," and "Ass."

Stevens and his team will coordinate directly with Texas public school districts to distribute the posters, invoking equal access under existing First Amendment protections. Districts refusing these posters may face legal challenges highlighting selective enforcement and religious discrimination.
